

# The Battle of Ridgefield CT




## The Battle

The Battle of Ridgefield was a battle and a series of skirmishes between American and British forces during the American Revolutionary War. The main battle was fought in the village of Ridgefield, Connecticut, on April 27, 1777. More skirmishing occurred the next day between Ridgefield and the coastline near Westport, Connecticut.

On April 25, 1777, a British force landed between Fairfield and Norwalk (now Westport) under the command of New York's Royal Governor Major General William Tryon. They marched to Danbury, where they destroyed Continental Army supplies after chasing off a small garrison of troops. Word spread concerning the British troop movements, and Connecticut militia leaders sprang into action. Major General David Wooster, Brigadier General Gold Selleck Silliman, and

Brigadier General Benedict Arnold raised a combined force of roughly 700 Continental Army regular and irregular local militia forces to oppose the raiders, but they could not reach Danbury in time to prevent the destruction of the supplies. Instead, they set out to harass the British on their return to the coast.



The company led by General Wooster twice attacked Tryon's rear guard during their march south on April 27. Wooster was mortally wounded in the second encounter, and he died five days later. The main encounter then took place at Ridgefield, where several hundred militia under Arnold's command confronted the British; they were driven away in a running battle down the town's main street, but not before inflicting casualties on the British. Additional militia forces arrived, and the next day they continued to harass the British as they returned to Compo Point on the beach in Westport where the fleet awaited them. Arnold regrouped the militia and some artillery to make a stand against the British near their landing site, but his position was flanked and his force scattered by artillery fire and a bayonet charge.

The expedition was a tactical success for the British forces, but the raid galvanized Patriot support in Connecticut.

#### Recreation of the Battle

The Town of Ridgefield CT does a recreation of this battle every 5 years or so. This will be the 245th Anniversary of the Battle. The Town has selected the 5th CT Regiment as its Reenactors and event planners for this upcoming event and in turn we would like to invite your unit to participate. This event will be open to all BAR member units and selected invited units. A healthy Stipend for your unit, will be based upon the number of Muskets and demonstrations you can provide. Everything from food to firewood will be provided to you by the event host and sponsoring units. Come be our guests.



#### The Event itself

The event will be held on April 29th thru May 1st of 2022. It will consist of encampments for both sides, one at Ballard Park in Ridgefield and the other at Jesse Lee Church at the other end of Main Street. Arrival and set-up will begin Friday afternoon for those who wish and again on Saturday morning prior to event start time. YTD. Friday evening will consist of an evening meal for those who wish to partake. The town has graciously agreed to provide all essentials such as wood, water, portajohns, and all emergency services. Saturday will start with Breakfast provided for all reenactors at either a central location or near each encampment, sponsored by local community groups. Each camp will provide demonstrations for the public throughout the

weekend please let us know what demos your unit would like to provide on your registration form . THIS EVENT WILL BE MOSTLY MILITIA SO PLEASE DRESS ACCORDINGLY and practice your 64 drill. Regimentals will be for selected Officers only. Hunting shirts will suffice but traditional New England Militia clothing should be your first choice. Standard 3 day max beard growth will also be in effect. Around 11am each army will form up on their respective parade grounds and do a formal inspection and safety check and apply BAR safety rules, as well as be provided provisions for lunch after the Battle. They will then begin to move to their respective starting locations. At about 11:45am the action will begin at a location further up on Main street and head in a southern direction. The Militia will erect three barricades along the route for the British to encounter and these three areas will be focal points for the public to gather. Local youth organizations with adult supervision will help erect these barricades and remove them as the Battle passes. At the barricades militia units will attack and retreat from the sides as the British column advances. To the rear will be Regular Continental Soldiers harassing the rear guard as well. The Battle will end at Jesse Lee church where both armies will form up and engage the public. This would also be a great location to do "people of the Armies" talk or Battlefield Surgeons Demonstrations. By 2pm both Armies should return to their camps and resume afternoon demonstrations. Between 5-6pm Dinner will be provided. 7pm a Tavern for

#### 1. Additional activities

\*Before the battle the Generals will make an appearance. General Arnold, General Wooster, and General Sillimen. We will also have a portrayal of Syble Luddington, all on horseback and they will parade down main street.

#### 2. Artillery

The British will have mobile Artillery in their column. Part of the local history is that during the battle a British cannon was fired and the ball struck the keeler tavern where it lodged itself into the corner post of the building. It remains there still to this day.

#### Great Honor

To close this event all reenactors will have the honor and privilege to partake in a once in a lifetime event. Let me preface this with the *discovery of Human skeletal remains that possibly belong to Revolutionary War soldiers who fought in the Battle of Ridgefield in 1777. They were discovered under the foundation of an early 18th-century house on Main Street.* 

The Connecticut Office of State Archaeology was notified by the Office of the Chief Medical Examiner about the find on Dec. 2. Subsequent excavations by state archaeologist Nicholas Bellantoni, with assistance from the Friends of the Office of State Archaeology, Inc. and University of Connecticut graduate students, have yielded two more skeletons. A total of 4 Skeletal remains were unearthed.

The plan is to bury these soldiers on Sunday with both sides represented, as it is unlikely that they will definitely discover which side they were on. The town is currently building wagons and has horses to pull caskets. We will provide a military honor guard for this historic event.

#### Conclusion of the weekend

The event will conclude directly after the funeral. Camps may be struck and f**or those who participate in the whole weekend and funeral will receive a momento.** (YTD)
